Today, 90% of the data available in the virtual world has been formed in the last 5 years.

And the performance of such a high level of complex tasks, in turn, dictated the use of special methods of analysis. The most common methods include such methods as "Hashtek analysis" ("Hashtag tracking"), "system analysis" ("Network analysis"), "text tone analysis" ("Sentiment analysis"), and "opinions")

and views" ("Opinion mining"). These methods give the faith to get the answers to the questions you need by studying the opinions and discussions expressed on a particular topic that has the greatest interest. In particular, the method" text tone analysis "("Sentiment analyses") is used to determine the identity of users and their political status, as well as to assess the reactions of participants in the discussion with respect to the topic.information and communication technologies, in particular, digital technologies, have a strong position in murkkab and rapidly changing international relations, occupy an important place in the effective implementation of the priority tasks within the framework of the state's foreign policy and foreign economic activity.
