 distance learning is considered open, it gives all those who want the opportunity to receive education; • Distance Learning makes it possible to use different level of curriculum;



Despite the variety of opinions of specialists in the field of specific features of distance learning, almost all authors express the following points about the following key features of distance learning: flexibility, modularity, convenience, economic efficiencyadorlik, the speed of communication, the breadth of coverage, technologicality, social equality, the new role of tutor, the specific control of quality.

1. Flexibility is the ability to choose, implement the learning process according to time, place and duration of study. In the system of distance learning, the educators will not only participate in continuous training, mainly in the form of lectures and seminars, but will also

be able to work at a convenient time, place and at a comfortable pace for themselves.

- 2. Modularity-the content of distance learning provided in the modules allows the educator to create an individual training tray in accordance with the need for personal knowledge.
- 3. Convenience-does not depend on the place of residence and economic opportunities of the educated;
- 4. Economic efficiencyadorlik-economic efficiency qisqar is a reduction in the costs of an educational institution (such as utility bills, occupied space fees, etc.) as well as the costs of receiving education (road fees, accommodation costs, etc.). Spending on educational services can be reduced by approximately 50-60% compared to traditional ones.
- 5. The urgency of communication is the presence of a rapid mutual re connection between the tutor and the educator.
- 6. The breadth of coverage-that is, distance learning is the audience that is intended for learners in a particular area, since it does not require room, it is possible to cover the learners in the desired area with distance learning.
- 7. Technologyism is the effective use of new information and communication technologies in the learning process.
- 8. Social equality is a kind of condition and opportunity created for everyone in reading through a remote form, regardless of their health and socio-economic conditions.
- 9. Internationality-availability of convenient and fast opportunities for export and import of World achievements in the service market of education in the implementation of educational goals and objectives.
- 10. The new role of the teacher is that the tutor is a consultant-teacher in their personal and professional development, organizing independent educational and cognitive activities of the educators in a special psychological-pedagogical and information and communication technologies environment.
- 11. Specific control of the quality of education as a form of control in distance learning, remote examinations, dialogues,

practical, course and project work, extracurricular, computerised test systems are used. It is worth noting that the control of the quality of distance learning is a solution to problems, compliance with the standard of education is of great importance for the success of the entire system of Education.
