Today, youth education in our country has been raised to the level of state policy, and on the basis of this, it is one of our main tasks to protect young people, who are the creators of our future, from various foreign ideas and aggression in the age of struggle between ideologies, in order to capture the human heart and mind. As the President of the Republic of Uzbekistan, Shavkat Mirziyoyev, said, "Education of the young generation has always been important and relevant. But in the 21st century in which we live, this issue is really becoming a matter of life and death" [1. p. 504-505].

One of the main tasks of modern education today is related to the development of students' competence in legal, professional, national, spiritual-educational, ideological-ideological and cultural terms. Compliance with international educational standards requires the inclusion of ideological-ideological, spiritual-educational aspects in the educational

content. The next stages of socio-economic development require the supply of competent individuals who can think globally, find their way in various socio-economic, political and legal situations, armed with progressive ideas and ideology. The higher education system plays a leading and decisive role in the preparation of such persons.

Pedagogical higher education institutions play an important role in forming the professional competence of future teachers, in educating them with high moral qualities, ideological maturity, citizenship and patriotism. Therefore, one of the main tasks of pedagogic higher education institutions reflects the issue of developing legal consciousness and legal culture among students, as an important factor of ideological and ideological competence.

The main legal basis for the development of science and its state support in our country is determined by the Constitution of the Republic of Uzbekistan. Article 42 of Chapter IX of the

In the Decree of the President of the Republic of Uzbekistan dated January 9, 2019 No. PF-5618 "On fundamental improvement of the system of raising legal awareness and legal culture in society", the following are defined as the main tasks of raising legal awareness and legal culture in society:

- to form a system of consistently conveying to the population the content and essence of the socio-economic reforms, adopted laws and state programs, and instilling in the minds of citizens "the spirit of respect for laws in society is the guarantee of building a democratic legal state!" to strengthen the idea of life;

- in raising legal consciousness and legal culture in the society, first of all, special attention should be paid to the systematic and organic conduct of education, starting from the pre-school education system, instilling legal consciousness and legal culture in all layers of the population, maintaining the balance between personal interests and the interests of society are tasked with extensive promotion [4].

Systematic organization of political-legal, spiritual-educational activities dedicated to raising the legal consciousness and legal culture of citizens in the society, developing their legal knowledge through constitutional rights and duties, norms of etiquette. It is desirable to preserve our religious and national values, customs and traditions in young people, and educate them in the spirit of involvement in the events happening in our society.

In other words, respect for the Constitution and laws, legal awareness and culture should become the way of life and activity of every citizen, every official" [5]. He emphasizes that the role of our Constitution and laws is incomparable in the development of legal consciousness and culture of citizens, in fulfilling their duties and obligations to the Motherland.

The "Concept of developing the higher education system of the Republic of Uzbekistan until 2030" approved by the Decree of the President of the Republic of Uzbekistan No. PF-5847 of October 8, 2019 "On approval of the concept of the development of the higher education system of the Republic of Uzbekistan until 2030" is directly related to the development of ideological and ideological competence of students the following tasks are defined:

- students have not developed the skills of critical thinking, independent search and analysis of information;
- to strengthen spiritual and moral content in higher education, to educate young people in the spirit of patriotism based on respect for national values, humanitarianism and high spiritual ideals, to further develop their immunity against foreign ideas and ideologies [6].

Today, which is called the age of globalization, the factor of education and upbringing is important in protecting young people from aggressive ideas. Because since time immemorial, education carried out in the direction of good goals has always shown its positive results.

Improvement of the system of spiritual and educational work in our country has always been a priority. For example, in the Resolution of the President of the Republic of Uzbekistan No. PQ-5040 of March 26, 2021 "On measures to fundamentally improve the system of spiritual and educational affairs" implementation of comprehensive measures aimed at eliminating vices such as irresponsibility; increase the population's culture of using the Internet global information network, strengthen their ideological immunity against ideological and

informational attacks; achieving the primacy of moral and ethical standards, national and universal values in culture, literature, cinema, theater, music and all types of art, publishing and printing products, mass media; regular study of geopolitical and ideological processes, effective ideological struggle against terrorism, extremism, fanaticism, human trafficking, drug business and other dangerous threats, and development of international cooperation in this regard" [7] priority directions for radical improvement of the system of spiritual and educational affairs was marked as.

As an important factor of legal culture in future specialists, the development of ideological and ideological competence in future teachers is first of all closely related to their upbringing in the spirit of respect for the national idea.

As stated in the Address of the President of the Republic of Uzbekistan Shavkat Mirziyoyev to the Oliy Majlis on December 28, 2018, "We need to develop a national idea that will be a source of strength for us in the implementation of the great tasks we have set before us" [8]. In the process of addressing the Oliy Majlis, these points were not emphasized for nothing, of course. Because today, in the era of increasing ideological threats and ideological attacks in the world civilization, it is necessary to protect the youth of our country from various dangers, it is necessary to develop the national idea, to form the ideological immunity of the youth against evil ideas.

In order to develop ideological and ideological competence in students, it is necessary to carry out ideological prevention work correctly. Ideological prevention is a set of ideological, educational, spiritual, ideological works of various forms carried out by social institutions, and this important process includes the system of ideological education today.

It is important to use various methods and tools in the implementation of ideological prevention. It is necessary to carry out preventive measures to protect young people from ideological attacks at different rates and step by step.

If preventive work is carried out continuously and steadily in pedagogical higher education institutions, the future teachers will achieve a harmonious development of both ideological and ideological competence and skills specific to the propagator of spiritual and educational works.

While noting that improving the socio-spiritual environment in our country and protecting young people from ideological aggression and ideological attacks is one of the main tasks facing the society, President Sh. Mirziyoev also emphasized the following points: "In this sense, the call to protect your child, which is becoming widespread in our country today, should not be just empty words, but should penetrate deep into the hearts and minds of every parent, every citizen, and become a practical action" [1. p. 531-532].

In his speech at the 72nd session of the United Nations General Assembly, the President of the Republic of Uzbekistan Shavkat Mirziyoyev proposed the adoption of the UN Convention on Youth Rights. Based on this, the President cited the fact that the number of young people has exceeded two billion, and the need for protection of young people at a time when international terrorism and extremism are growing rapidly, as important factors.

Based on the tasks defined in the above-mentioned regulatory and legal documents, it was concluded that the development of ideological and ideological competence in students is an important factor of legal culture. In order to justify this opinion, first of all, it is appropriate to dwell on the concepts of legal consciousness and legal culture.
