Analysis of results and conclusions. Based on these goals, the government is taking global measures to reform the economy of the country and its regions in 1995-2021 and to date. In particular, during this period, reforms were carried out to modernize and diversify the industrial sectors of the regions, improve production and social infrastructure, localization of the regional economy, liberalization of the banking and financial sector and fiscal policy were adopted and

implemented. provided sustainable growth (Figure 1).

In general, real GDP growth in the country's regions for 1995-2020 was positive, ranging from 2.8 times in Navoi region (the lowest GRP growth in the analyzed period) to 7.3 times in Tashkent. During this period, the country's GDP growth was 4.1 times. In the analyzed period, the highest growth rates of gross regional product were achieved in Andijan region (5.4 times), Samarkand (4.9 times), Jizzakh region (4.9 times) and Tashkent (6.7 times). In the remaining regions, the country's GDP growth rate was low compared to the country's GDP growth rates for 1995-2021.

As noted above, the overall economic situation of the country is directly related to the state of the regional economy. Given the role and importance of the regions in the formation of the country's GDP, there is a need to analyze the factors influencing their position. Andijan region has been included in this group since 2000. All of the regions listed above have exceeded the 7% threshold in the formation of the country's gross domestic product. For 1995-2021, Andijan, Navoi and Surkhandarya regions significantly increased their influence on the country's economy, while Khorezm region significantly reduced its participation. It should be noted that, in general, during the analyzed period, positive economic growth was observed in all regions of Uzbekistan, which, in turn, ensured the growth of the country's economy. However, along with economic growth, the stratification of the regions of Uzbekistan in terms of economic development has increased significantly. The growth of regional stratification was due to the fact that the economic growth rates of the regions varied, i.e., economic growth was high in some regions and moderate in others.

1. Taking into account the threats and consequences of the coronavirus pandemic for the regional economy, it is necessary to develop and adopt a medium and long-term "Regional Development Strategy", which identifies the main directions and priorities of socio-economic development of Uzbekistan and its regions.

- 2. Based on the tasks set out in the developed regional development strategy, the implementation of strategic programs in the region by the bodies responsible for the socioeconomic development of the regions and their territories should be constantly monitored and constantly monitored.
- 3. It is necessary to increase the role and responsibility of local authorities in developing the business environment and creating a level playing field for investors.
- 4. One of the most important tasks is to further develop the human resources of the regions, to use effective methods of organizing science and to bring it into the business process.
